EXECUTIVE COUNCIL THE FLORIDA BAR HEALTH LAW SECTION

January 17, 2008

I. Call to Order

The meeting was called to order by Chair, Laurie Levin, at 2:40 p.m. in the Tuttle South Room of the Hyatt Regency Hotel, Miami, Florida. Executive Council members in attendance either in person or via telephone were: Harold Kaplan, Laurie Levin, Lewis Fishman, Monica Rodriquez, Jodi Laurence, Lester Perling, Troy Kishbaugh, Spencer Levine and James Farrell. Also in attendance either in person or via telephone were: Bernabe Icaza, Chet Barclay, Valerie Yarbrough, Al Robinson, Lois Shepherd, Stacie Handwerker and John Buchanan.

II. Opening Remarks - Laurie Levin, Chair

Laurie Levin opened the meeting by welcoming everyone. Ms. Levin introduced Al Robinson from Navigant Consulting and thanked him and Navigant Consulting for sponsoring the reception to follow the meeting. Mr. Robinson spoke briefly regarding Navigant Consultant's services and distributed a brochure. Mr. Robinson discussed the current Medicare audits being conducted by the recovery audit contractors and how Navigant Consulting could assist with these audits.

Laurie Levin introduced Lois Shepard, who is the new Florida State University health law professor. Ms. Shepard has taught health law for fifteen years. She briefly reviewed her experience and interests.

III. Approval of Previous Minutes – Lester J. Perling, Secretary

The amended minutes for January 18, 2007, and June 28, 2007, were reviewed. Lewis W. Fishman noted that he is a member of the Executive Council and should have been noted as such in both minutes and also noted others who are members of the Executive Council were not properly listed as such. Valerie Yarbrough stated she would correct this. The amended minutes were approved based on this upcoming revision.

Mr. Perling presented the September 6, 2007, minutes and these were approved.

IV. Financial Report - Troy Kishbaugh, Treasurer

Mr. Kishbaugh presented the financial report. He noticed a net increase of the Section funds balance from the same period last year of approximately \$40,000.00 with a balance of \$110,000.00. Mr. Kishbaugh reported that there was a greater loss for continuing legal education but did not have the detail with regard to this loss and he requested that Ms. Yarbrough provide this detail to him so it can be reviewed. There was some discussion with regard to how to handle the current surplus. Some concern was expressed whether The Florida Bar could take the money if not spent but it was generally agreed that this was not a serious concern because other sections have larger surpluses that have existed for some time. The proposed budget for the 2008 – 09 fiscal year was discussed briefly. The Budget Committee will review this in greater detail.

V. Council of Sections – Harold Kaplan

Mr. Kaplan reported that the Young Lawyer Section has established a mentoring program in every substantive area and is seeking mentors for health law. The Bar is considering making a mentoring program mandatory for all new lawyers. Mr. Kaplan noted that the next meeting of the Council of Sections has been cancelled.

VI. Committee Reports

A. Education, Training & Information – Jeanne Helton

Ms. Helton noted that Charmiane Chiu is finalizing three telephonic CLE programs including hospital compliance; physician dispensing; and handling disruptive physicians in conjunction with the Professionals Resource Network.

The CLE program for June is in process. There will be sessions on a recent Board of Medicine decision regarding sleep laboratories; a legislative update by the Florida Medical Association; a presentation on retail clinics; and a topic to be determined. It was reported that the Representing the Physician 2008 program had over 90 registrants. The preparation for the certification course is coming to a successful conclusion.

B. Section Effectiveness – Lew Fishman

Mr. Fishman had nothing new to report on law school outreach. He reported that it was time to select a Nominating Committee. Harold Kaplan, Jodi Laurence and Bernieb Icaza volunteered. Laurie Levin will follow up on making further nominations. The positions that need to be filled are the Chair Elect, Treasurer and Secretary and terminating Executive Council members.

Jeanne Helton reported that she, along with other Section members, conducted a program at the Coastal School of Law that 55 students attended. Harold Kaplan reported that he has contacted Nova Southeastern University but was told that there are not many students interested in health law at that the Law School was not particularly interested in an outreach program. There was discussion concerning this and a belief stated that there is in fact interest in health law. Jodi Laurence and Harold Kaplan will follow up with Nova Southeastern University.

A discussion was held whether medical schools typically offer health law courses and whether the Section could assist with this. It was the Committee's belief that generally there is not time in the curriculum to offer these courses and it likely would not be a fruitful area to explore at this time.

C. Communications & Technology – Bernabe Icaza

i. Website – Chet Barkley

Mr. Barkley reported that the website is still active. It has incurred modest maintenance fees of approximately \$200.00 per month. The website is updated frequently with new material being posted.

ii. Newsletter – Bernabe Icaza

Laurie Levin noted that the last edition of the newsletter received excellent reviews and thanked Mr. Icaza for his work. Mr. Icaza stated that he is currently soliciting articles for the next issue with a deadline of the end of February. He asked that if any section members intended to submit an article to please let him know by February 15th. Mr. Icaza stated that he is investigating the requirements for publishing articles that have been previously published but there does not appear to be a Bar policy on this issue. He noted that it is necessary to have permission to do so. He stated his willingness to publish previously published articles but that it was agreed that better placement would be given to original articles.

D. Health Information Technology - William Dillon

Mr. Dillon reported that several Section members are participating with the Agency for Health Care Administration in a security working group. They are studying barriers imposed by State law with regard to health information exchange. There is proposed legislation that would affect such exchange. The Committee will review this legislation once filed and report back to the Section with any concerns.

VII. Old Business

A. Health Law Handbook 2009 – Jeanne Helton and John Buchanan

Ms. Helton and Mr. Buchanan reported that they are working on the 2009 edition of the Health Law Handbook. They also noted that the 2007 handbook is still selling well. First drafts for chapters for the 2009 are due on July 31, 2008, with final drafts being due on September 30, 2008. The goal is to print by November 1, 2008, so that it will be available at the January 2009, Bar Meeting. Commitments have been received from current authors and Ms. Helton and Mr. Buchanan are also considering new chapters. The new chapters being considered include: The Schiavo case, navigating restrictive covenants for health care providers, long term care issues, dispensing pactitioners, and practical pointers on medical staff credentialing and privileges.

The Alabama Bar Association has agreed to post a link on its website to information regarding the Handbook that will allow Alabama Bar Members to purchase it in exchange for an agreement that we post such a link on the Sections website if they prepare a health law handbook.

VIII. New Business

A. New Public Health Committee - Laurie Levin

Ms. Levin asked Rodney Johnson to discuss the goals of this proposed Committee. These include disease surveillance and prevention of diseases, i.e., traditional public health issues. A motion was made and seconded to form a public health committee. The motion passed unanimously. Laurie Levin appointed Rodney Johnson and Walter Carfora to chair this new committee.

B. Review and Approval of 2009-2010 Budget

Please see discussion under financial report above. Approval of the budget was deferred until reviewed by the Budget Committee following which there will be a telephonic meeting for review and approval.

C. Agency for Disabilities Volunteers – Laurie Levin

Alan Grossman discussed this issue in detail. This is in response to a request for pro bono representations for persons with disabilities before the Division of Administrative Hearings. George Indest recommended that this would be a potentially better project for a law school clinic then the Section. Dr. Sheppard noted that Florida

State University has such a program. It was discussed that the hearings occur all over the State and not only in Tallahassee. No further action was taken.

D. 2008 Metal of Honor Award – Laurie Levin

Ms. Levin discussed that she received a call for nominees from The Florida Bar Foundation for 2008 Metal of Honor Award winners. This reward recognizes outstanding achievements by Florida residents in approving the State's justice system. Information concerning the award was disseminated including nomination forms.

IX. Chair – Elect Comments – Jeanne Helton

Ms. Helton says that she is looking forward to the coming year. Her primary goals is to get more members involved in the Section and insuring that members feel that they are getting value for their money.

X. Adjournment

Ms. Levin announced that the next Executive Council meeting would be held on June 19, 2008, at the Florida Bar Annual Meeting at the Boca Raton Resort and Club. The meeting was adjourned at 4:15 p.m.

Consistent with the provisions of Standing Board Policy 9.20(d), all Florida Bar legislative positions for the 2006-08 biennium - to include those of committees, sections and divisions - are to be "sunsetted" at the July 25, 2008 meeting of the Board of Governors.

Attached is a current listing of recognized positions for your division, section or committee. Please review your group's existing positions for moot or stale issues, and advise which items you deem worthy of continued advocacy in the 2008-10 biennium which begins upon the legislature's organizational session next fall. For convenience, you may return a marked copy of this attachment that indicates your preferences.

Existing section positions that are recommended by you for continuation in the new biennium are typically rolled over by the Bar's governing board without any additional formality. Your prompt response should allow for timely action by the board at its July 2008 meeting without the lapsing of any current stance. However, any request for entirely new legislative positions by your group must be tendered in more complete form.

Existing "Big Bar" positions and those of committees or divisions - which are supported by mandatory membership fees - are treated differently. Following the sunset of these particular positions, the Board of Governors typically leaves that slate blank until at least the next board meeting. Any positions in these categories that are considered after this lapse (whether similar to previous ones or not) are reviewed de novo and treated as new in every respect - particularly for purposes of member dissent and potential fee rebates under R. Regulating Fla. Bar 2-9.3. Regardless, if you have recommendations for Florida Bar, division or committee advocacy in the new biennium, please share them with us.

Health Law Section

July 28, 2006

- 1. Supports confidentiality of Physician Recovery Network records.
- 2. Supports, for administrative disciplinary proceedings before regulatory boards within the Division of Medical Quality Assurance of the Department of Health, the adoption of a statute of limitations of no less than four years from the time of the conduct giving rise to the complaint, or from the time the conduct is discovered or should have been discovered, but in no event should the statute of limitations be extended more than seven years -- said limitations being inapplicable in cases involving: fraud, concealment or intentional misrepresentation of fact by the investigated licensee which affect discovery of the alleged misconduct within the limitations period; a complainant whose minority, incapacity or other legal impediment prevented discovery of the alleged misconduct within the limitations period; claims of sexual activity between a licensee and patient; or alleged conduct that involves fraud or misrepresentation of a material fact in the context of an original or renewal license application.
- 3. The Health Law Section opposes legislation that imposes onerous financial burdens on health care licensees:

who elect or are required to participate in the state"s impaired practitioner program;

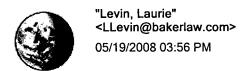
who elect to exercise rights provided pursuant to Chapter 120, F.S.;

who are subjected to the unilateral assessment of costs, rather than those limited to a non-prevailing party; or

who are subjected to mandatory disciplinary fines incapable of discretionary adjustment by an agency.

- 4. Supports amendment of §456.072, Florida Statutes; to provide the Board of Medicine with discretion regarding the imposition of costs against any party; to permit assessment of costs on an individual basis; to provide a mechanism for determining such costs; and to exclude attorneys" fees from costs, as in matters of civil litigation.
- 5. Opposes any amendment to Chapter 120, *Florida Statutes*, or other legislation, that undermines the rule-making requirements of the Administrative Procedure Act by allowing statements of agency policy without formal rule-making.
- 6. Opposes any amendment to Chapter 120, *Florida Statutes*, or other legislation to deny, limit or restrict points of entry to administrative proceedings under Chapter 120, *Florida Statutes*, by substantially affected persons.
- 7. Opposes exemptions or exceptions to the Administrative Procedure Act, but otherwise supports a requirement that any exemption or exception be included within Chapter 120, *Florida Statutes*.
- 8. Supports voluntary use of mediation to resolve matters in administrative proceedings under Chapter 120, *Florida Statutes*, and supports confidentiality of discussions in mediation; but opposes mandatory mediation and opposes imposition of involuntary penalties associated with mediation.

- 9. Supports uniformity of procedures in administrative proceedings under Chapter 120, *Florida Statutes*, and supports modification of such procedures only through amendment of or exceptions to the Uniform Rules of Procedure.
- 10. Opposes amendment to Chapter 120, *Florida Statutes*, that limits, restricts, or penalizes full participation in the administrative process, in the absence of compelling justification or non-anecdotal evidence which demonstrates that the existing provisions of law are not adequately protecting the administrative due process rights of all participants.
